Dear Ms. Schum,

A request for amendment to the ownership of Titan Associates Corporation, was received on October 15, 2019. After a thorough review, the Indiana Department of Administration, Division of Supplier Diversity has determined the firm is eligible for an amendment to the previously granted certification as WBE, Women Business Enterprise.

This determination is based on information and documentation submitted to us, which indicates that the company is owned and controlled by at least 51%, as a regulatory minimum for purposes of certification as WBW. Also, as previously indicated on the certification letter dated on 09/05/2019, the company provides a commercially useful function in the areas listed below as it is now currently certified in:

Although your certification is valid for a three-year period, you are required to submit an annual Affidavit of Continued Eligibility, which reflects updates regarding the issues critical to maintaining your certification. However, you must notify us immediately if any changes occur. Failure to notify us of changes or to provide the Affidavit of Continued Eligibility form annually will result in revocation of your certification. Changes include, but are not limited to:


- Change in location or contact information (address, phone number, e-mail address, etc.)
- Change in services provided (amendment to certification)

- Change in ownership
- Change in control
